- \_\_\_\_\_ November – December 2020 (89% of face value of tax credits)

**NOTE:** Credits must be purchased by December 31<sup>st</sup> in order to be used against that year's taxes. Credits will be matched on a registration basis; therefore, the earlier you register, the better are the chances you will get credits by the end of the year.
