**Credit Purchase**

We have **three types of credits** that will be available throughout the year. They include **Conservation Easement, Environmental Remediation (brownfield), and Historic Preservation credits**. We will let you know which type of credit you are purchasing when they are made available, as you are always welcome to pass if you would prefer a different credit type.

Credits can be purchased at three different levels – Silver, Gold, and Platinum. Though slightly more expensive, Platinum buyers will have first dibs on buying credits that are made available. Once all Platinum buyers have purchased credits or have chosen to pass, we will offer credits to Gold buyers, and so on to Silver. Because it can be hard to forecast which of your clients are going to need tax credits for the year, we will allow accountants to reserve as many blocks of \$300K worth of credits for their clients as needed without specifying which clients will be using them.
